Audrey Stone **agreed** to notify the TWU Local 556 Board of Election of the Executive Board's decision.

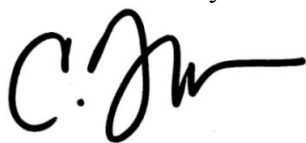
