Among the many congratulatory notes your Negotiating Team has received over the past few weeks regarding the new Contract, quite a few of them have suggested that we take a well-deserved vacation. A vacation would be nice, I admit, but I'm happy to say that we still have plenty to keep us busy as our Union continues to move forward for our Members. Our Negotiating Team has kept busy working on the

gains in our Agreement as soon as possible. Remember there are over 200 changes in automation alone, but the Company has been diligent about working with us to ensure they are all in effect (and operating correctly) as soon as possible. With the help of some additional Members, the NT is also working on a frequently asked questions document for the new Contract, as well as a Contract resource guide to be published soon. We are also training our great Grievance Team on the changes in the Contract, so that they are always ready with the right answers. Additionally, both the Grievance Team and the Arbitration Team are reviewing our past grievances

with the Company, including any that may be obsolete under the new Contract language. For those where we cannot seek resolution, our Arbitration Team will be making a concerted effort to take numerous cases to Board of Adjustment and Arbitration throughout the summer. We will be training several Team and Executive Board Members in BOA/Arbitration preparation and presentation, and hope to satisfactorily resolve as many grievances as possible before the end of the year. I am in the process of interviewing candidates for the Grievance Chairperson position, and the new Chair will have a well-trained Team when they take over. Your new Executive Board hit the ground running with several exciting projects including a

Member-driven initiative called "Project Redesign" to develop a strategic plan to strengthen our Union and make it more accessible to our Members. June Membership Meetings held so far have had very full agendas, as will the remaining Meetings

in Houston, Las Vegas, Oakland, and Phoenix. In addition to addressing Membership Motions on the table, this is the meeting where amendments to our Bylaws can be proposed, and they will be voted on in the following meeting. Our Bylaws are the framework by which our Union is run, so please remember that any amendments to the Bylaws must comply with the TWU Constitution and all Labor Laws. Furthermore, there will be nominations and elections for very important positions:

meeting. Shop Stewards are our most basic—and most important—form of Membership Representation. As a Shop Steward, you are the face of the Union in your base.


Shop Stewards will be nominated and voted on in each
