The Board positions to be reduced to 2 years in the 2003 election only, will be chosen by lot with the following exception: The term of President and Treasurer would not be included in the lots. The term of President will be among the 4 year terms and the Treasurer will be among the 2 year terms. The Board of Election will draw lots no later than 30 days prior to the first Membership meeting where nominations will take place.

This motion does not create a new assessment fee, but reaffirms the existing fee and only ensures that the voting procedure is done in accordance with LMRDA-TITLE I Bill of Rights of Members of Labor Organizations (29 U.S.C. 411), SEC. 101. (a) (3) DUES, INITIATION FEES, AND ASSESSMENTS" at this, the Third Membership Meeting 2006. Secret ballots 1-71, on which the text of the motion appeared, as well as the number of the secret ballot, date and Membership Meeting Session, were distributed at the Meeting. All secret ballots were returned. One ballot was unmarked. One ballot was torn into small pieces.

"For the Local 556 to research and establish electronic technology to promote more inclusion for membership meetings and membership information."
